PARADE Guidelines/Information

Date and Time: December 5, 2015 – Community of Royal, 10:00 a.m.

Line-up: Will begin promptly at 9 am at Mr. Nathaniel Williams' Home, 374 West County Road 462, Wildwood (Royal), FL 34785.

Political: We do not allow political candidates or publicity of such, social issues and/ or targeted special interest groups. The parade committee has final decision authority.

Start Time: Step off will take place at 10:00 a.m. Late arrivals will be assigned to the rear of the Parade despite assignment of Entry Number.

Parade/March Route: Begin at 374 W. County Road 462 continue to County Road 235A ending at Alonzo A. Young, Sr. Enrichment & Historical Center's Open Holiday House featuring vendors, historical presentations, holiday concert, fun & games, immediately following parade.

Entry-Safety: Each entrant must maintain a distance of 1 car length between your entry and the entry in front of you.

Music & performances: Must be suitable for a family audience.

Equine/Animals: Entry Units must provide their own pooper-scoopers and may be placed at the rear of the lineup. Participants are responsible for the safety of their animals.

Distribution of flyers, candy, and gum: May be distributed by individuals walking the Parade route and **not tossed or handed from** the float, car, truck, horse, motorcycle, etc.

**** Entry fee: FREE**. Donations accepted.**

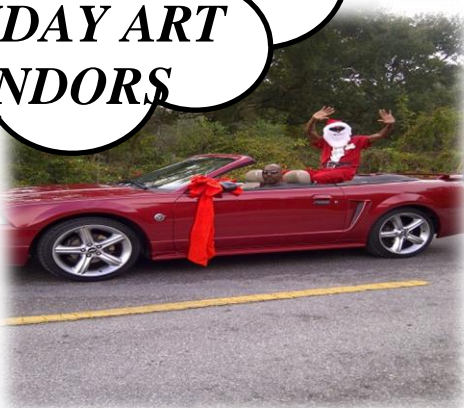

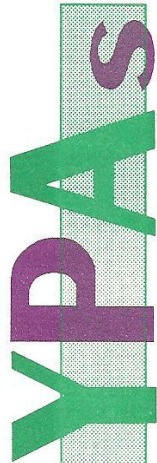
