- Deadline: **virtual** performances must be submitted by November 2, 2020, midnight via Dropbox per discipline.
- Also, your paper application must be signed & emailed: youngartists@aol.com; or text:352-603-3409 by November 2, 2020 deadline. Completed in its entirety or disqualified.
- Past YPAs, Inc. placers & competitors are eligible to compete; must submit a new application.
- You must submit your **virtual** competition performance entry via the following DropBox links, according to discipline:

- Judges Panel will consist of, at least, one professional judge in each discipline. The lead judge will rotate as each category is judged.

Please watch your **virtual** performance time: There is not a penalty for stopping a performance to honor time limits.
